

#### **DEFINITIONS OF VEHICLE CATEGORIES**

#### Category M:

M Motor vehicles with at least four wheels designed and constructed for the carriage of passengers.

- at least four wheels or
- with three wheels and a maximum weight over 1 tonne
- [articulated vehicles of two non-separable, articulated units shall be considered as single vehicles]

Vehicles designed and constructed for the carriage of passengers and comprising no more than M₁ eight seats in addition to the driver's seat.

 $M_2$ Vehicles designed and constructed for the carriage of passengers, comprising of more than eight seats in addition to the driver's seat, and having a maximum mass not exceeding 5 tonnes.

 $M_3$ Vehicles designed and constructed for the carriage of passengers, comprising of more than eight seats in addition to the driver's seat, and having a maximum mass exceeding 5 tonnes.

#### **Category N:**

Motor vehicles with at least four wheels designed and constructed for the carriage of goods. N N₁ Vehicles designed and constructed for the carriage of goods and having a maximum mass not exceeding 3,5 tonnes.

Vehicles designed and constructed for the carriage of goods and having a maximum mass over  $N_2$ 

3,5 tonnes but not exceeding 12 tonnes.

Vehicles designed and constructed for the carriage of goods and having a maximum mass  $N_3$ 

exceeding 12 tonnes.

#### Category O:

Trailers (including semi-trailers) O:

O<sub>1</sub> Trailers with a maximum mass not exceeding 0.75 tonnes.

 $O_2$ Trailers with a maximum mass exceeding 0,75 tonnes but not exceeding 3,5 tonnes.  $O_3$ Trailers with a maximum mass exceeding 3,5 tonnes, but not exceeding 10 tonnes.

 $O_4$ Trailers with a maximum mass exceeding 10 tonnes.

#### CHAIRMAN'S REPORT FROM NOISE WORKING GROUP 8th FEBRUARY 2011

Representatives from Alexander Dennis Ltd, Brigade Electronics, Ford, Nissan Technical Centre, PSA and Vauxhall Motors attended this meeting.

This was the first "face-to-face" meeting of the Noise Working Group for just over 3 years, due to a long period of relative inactivity at a European level (GEB and GRB meetings). The Group discussed the following items:-

#### CONSTITUTION

The current Chair was re-elected. A Vice-Chair was then also elected, Hanns-Peter Bietenbeck of Ford, who is a regular participant at GEB/GRB.

#### **REGULATION 51**

There was a discussion on the VENOLIVA presentation from TNO who were contracted by the European Commission to carry out the analysis on the data obtained from the "monitoring" phase (2007 to 2010) of the implementation of the new test method, which had been presented at GRB-52. TNO proposed 5 different options as a result of the analysis, but the only viable option was to use the new test method with reduced limit values, implemented in a 2 stage approach.

OICA have concerns with some of the points raised in the TNO study; namely:

Conclusion that changes in tyre noise as a result of 661/2009 will give a 1.3 – 1.7 dB(A) reduction.
 Removal of the current allowances – OICA can accept this if vehicle classes and sub-classes are clearly defined.

Alexander Dennis also raised the issue that, so far, little consideration has been given to hybrid vehicles regarding the new test method.

#### ADDITIONAL SOUND EMISSION PROVISIONS (ASEP)

There is a formal document from the Chair of GRB to try to progress this subject.

#### QUIET ROAD TRANSPORT VEHICLES

Current Japanese proposal:

• Hybrids and electric vehicles should have a sound operating at vehicle speeds below 20km/h. Sound should not be louder than a standard engine noise and should be recognisable as a vehicle. It is expected that a revised version will be presented at GRB, but no document was available for review.

#### **DISCUSSION WITH DFT**

During the afternoon, the Noise WG was joined by Robert Falk and Chris Parkin of DfT.

- DfT International Standards Team will be reduced by 28% during the next few months. This obviously will have an impact on the areas that they can support. It is therefore important that they are kept involved in all subjects of importance to the UK Industry.
- The OICA document responding to the VENOLIVA report was presented to DfT.

  A discussion was held concerning the likely regulatory process from now forward. Some concern amongst NWG members and DfT that it will be dealt with by both EC and UN-ECE processes and that this may lead to difficulties.
