

DEFINITIONS OF VEHICLE CATEGORIES

Category M:

M Motor vehicles with at least four wheels designed and constructed for the carriage of passengers.

- at least four wheels or
- with three wheels and a maximum weight over 1 tonne
- [articulated vehicles of two non-separable, articulated units shall be considered as single vehicles]

M₁ Vehicles designed and constructed for the carriage of passengers and comprising no more than eight seats in addition to the driver's seat.

M₂ Vehicles designed and constructed for the carriage of passengers, comprising of more than eight seats in addition to the driver's seat, and having a maximum mass not exceeding 5 tonnes.

M₃ Vehicles designed and constructed for the carriage of passengers, comprising of more than eight

seats in addition to the driver's seat, and having a maximum mass exceeding 5 tonnes.

Category N:

N Motor vehicles with at least four wheels designed and constructed for the carriage of goods.
 N₁ Vehicles designed and constructed for the carriage of goods and having a maximum mass not exceeding 3,5 tonnes.

 N_2 Vehicles designed and constructed for the carriage of goods and having a maximum mass over

3,5 tonnes but not exceeding 12 tonnes.

N₃ Vehicles designed and constructed for the carriage of goods and having a maximum mass

exceeding 12 tonnes.

Category O:

O: Trailers (including semi-trailers)

O₁ Trailers with a maximum mass not exceeding 0,75 tonnes.

 O_2 Trailers with a maximum mass exceeding 0,75 tonnes but not exceeding 3,5 tonnes. Trailers with a maximum mass exceeding 3,5 tonnes, but not exceeding 10 tonnes.

O₄ Trailers with a maximum mass exceeding 10 tonnes.
