

### Foreign travel – I've got everything in hand!

Whilst researching for our imminent visit with a large UK group of 29 companies to EVS26 Los Angeles I came across an interesting US group – Westside Toastmasters – see their website link below for some interesting guidance on cultural differences and body language.

You may regularly travel internationally, but how aware are you for example of cultural differences in body language? For example: which countries wouldn't it be polite to use some of these hand gestures? The answers are listed at the end of the Bulletin.



Handshaking differences can also make for some embarrassing and humorous cultural encounters. British, Australian, New Zealand, German and American colleagues will usually shake hands on meeting, and again on departure. Most European cultures will shake hands with each other several times a day, and some French have been noted to shake hands for up to 30 minutes a day. Indian, Asian and Arabic cultures may continue to hold your hand when the handshake has ended. Germans and French give one or two firm pumps followed by a short hold, whereas we British give just three to five pumps compared with an American's five to seven pumps. So with a very full agenda at Los Angeles EVS26 next month - its certainly going to be all hands to the pump then!

# Indian Budget provides sops to micro, small and medium auto component sector; promotes R&D. No additional tax on diesels expected to push up the sale of these vehicles

The Indian budget for FY 2012/13 is seen as disappointing for the automotive industry in general, with expressions of displeasure at increased taxes and duties, although there have been small intermittent welcome reliefs. Excise duties have been increased for cars in all categories—12% for small cars (up from 10%) and in the range of 24-27% for large cars (up from 22-24%). Body building units of commercial vehicles will now attract an ad valorem duty of 3% instead of a specific duty of Rs 10,000 which is an additional burden on truck makers.

Michael Perschke, head of Audi India, commented that "The increase in excise and customs duty on large cars in this Budget is very surprising [...] This increase comes at a time when the automotive industry was finding favor with customers looking for better and efficient cars. We may now need to re-evaluate our pricing strategy in India." Both the Automotive Component Manufacturers Association of India (ACMA) and Society of Indian Automotive Manufacturers (SIAM) observed that such a step would have an adverse impact on the Indian automotive industry already impacted by rising fuel prices, inflation, high interest rates and slowing auto sales.

ACMA expects the increase in custom duty on flat-rolled steel from 5% to 7.5% to hit the component sector badly, considering that the component manufacturers use flat-rolled steel as a raw material to produce sheet metal components such as body panels and chassis.

The component sector though is expected to benefit from the government's initiative to set up an INR50bn (USD967m) "India Opportunity Venture Fund" to provide funding to the micro, small and medium (MSME) sector. MSMEs constitute over 70% of ACMA's membership and access to capital has been one of the major constraints for the sector. The decision to extend the weighted deduction of 200% of expenditure on research and development (R&D) for another five years is another positive step which will boost investments in new product development. The availability of skilled workforce had been a major challenge faced by the industry, so the introduction of weighted deduction of 150% for expenditure on skill development, will help the industry in bridging that requirement.

The concessional import duty on specified parts of hybrid vehicles has been extended to lithium ion batteries and other hybrid vehicle parts. This move is expected to help the hybrid and electric vehicle (EV) industry achieve better cost efficiency. The import of certain parts and lithium-ion batteries will now attract a special countervailing duty (CVD) with concessional excise duty/CVD of 6%. Excise duty on specified parts and lithium-ion batteries packs for hybrid vehicles is reduced to 6% from 10% till 31 March 2013. The government's decision not to levy an additional tax on diesel vehicles is expected to cause a spurt of investments in diesel powertrains. Several automakers, including Maruti Suzuki and Toyota Kirloskar, had held up their investments in new diesel engine plants due to lack of clarity on diesel vehicles and diesel pricing in India. Hyundai Motor India which had delayed its plan to set up an INR4-bn diesel engine manufacturing plant is likely to finalise the plan soon now. Last week's (23 March) reports also indicate that Maruti Suzuki may take a final call on setting up a diesel engine plant in Gurgaon, Haryana (India) in two months. Though the government may have put to rest all speculations of additional taxes on diesel vehicles, it is vet to garner a consensus on deregulating diesel pricing in the country which is ultimately going to affect the sale of these vehicles.

In general, the additional taxes will push up the vehicle prices in the country which may affect sales, impacting both OEMs and auto component manufacturers. The industry though is deriving solace from the expectation that due to the falling inflation, interest rates will soften and market sentiment will improve.

In December 2011, NHTSA published a notice of proposed rulemaking (NPRM) that addressed safety issues arising from increasing variations of keyless ignition controls, and the operation of those controls. We received a petition from the Alliance of Automobile Manufacturers requesting an extension of the comment period. The petitioner argued that additional time was needed to review information that was placed in the docket late in the comment period. After considering the petition, we are extending the comment period by 10 days, from 12 March 2012 to 22 March 2012.

This final rule amends the Federal motor vehicle safety standard for child restraint systems to expand its applicability to child restraints sold for children weighing up to 36 kilograms (kg) (80 pounds (lb)). This rule also amends the standard to incorporate use of a Hybrid III 10-year-old child test dummy (HIII-10C), weighing 35 kg (78 lb), in compliance tests of child restraints newly subject to the standard. In a companion document published elsewhere in this issue of the Federal Register, NHTSA is adding specifications and qualification requirements for the HIII-10C to our regulation for anthropomorphic test devices. This rulemaking establishes performance and other requirements for child restraints manufactured for children weighing 65 to 80 lb.

## Import Control System (ICS) safety and security – reminder of requirements for all courier traffic

The requirement to lodge an entry summary declaration (ENS) became mandatory across all Member States with effect from 1<sup>st</sup> January 2011.

As publicised in <u>CIP (10) 74</u> the EU Commission agreed to a period of leniency to enable businesses to fully test their systems using live data without fear of financial penalties. <u>CIP (11) 16</u> updated the EU position extending the period of grace to 30<sup>th</sup> June 2011. <u>CIP (11) 54</u> advised that the Import Control System (ICS) period of grace ended in the UK at midnight 30 June 2011. Carriers and / or their third party representatives therefore <u>must</u> ensure that they are fully compliant with <u>all</u> EU ICS regulations, including accurate completion of ENS data (as detailed in Regulation 2454/93 Annexe 30A) and conformance with the appropriate time limits. This Customs Information Paper (CIP) is being published as a reminder to all operators and carriers of courier traffic of their legal obligations and requirements for this industry sector.

#### **CUSTOMS INFORMATION PAPER (12) 09**

#### Import Account taken at an Excise Warehouse

Relevant for importers and import agents who declare third country excise goods for entry into an excise warehouse. Following a review of the policy on the examination of third country excise goods, the need for the Additional Information statement IRQ0C has been removed. The tariff will be amended in due course.
