# Let the FX dealers and Vatman help pay for your holiday!

I know you are all experienced travellers and I hope that business has been so good you will be able to enjoy a few days of well-earned rest and relaxation on holiday. But with the holiday season now upon us we can all do with a bit more cash in our bank account so I thought I would just write a timely reminder about two things we often overlook: exchanging foreign currency and recovering VAT paid in Europe – there's still just time before the end of September!

Anyone purchasing travel money should shop around and compare foreign currency rates. But remember, the majority of online comparison sites often have a commercial relationship with the exchange providers. "When is the best time to buy currency?" The simple answer is that there's no way of knowing but an unplanned purchase will inevitably cost you dear so my quick checklist is below. Yes I know you know – but how often do you actually follow the advice yourself – so tick them off below and if you cant tick them off – you should tick yourself off because its a hidden cost you could avoid by taking the right action?

- Shop online to get the best deal. Often provided with guarantees of the best price or the difference refunded.
- 2. Take a mix of cash and a prepaid travel money card. Foreign currency cards enable you to lock in your exchange rate at the time of loading and are separate from your bank account, which protects against theft or fraud.
- Be aware of hidden credit or debit card charges on overseas usage not just when drawing cash but also when buying goods or services and that cash withdrawal interest rates are particularly high.
- Avoid exchanging currency in your hotel or at the airport departure lounge if you
  do leave it to the last minute or after your arrival, look for a reputable bureau to
  change your money.
- Don't lose out on exchanging leftover currency. Many organisations will lock in rates for your residual currency at the same rate you purchased it, commission free.
- 6. If you only have large notes, try to break one when you arrive and before you get into the taxi from the airport, so you have smaller notes and coins on hand for incidentals tipping or taxis, who will not accept large denominations or if they do will not have change!
- Some countries restrict the amount of currency in or out of the country, while others don't permit you to take any at all. Check before departure.

With the process for reclaiming tax being quite complex, foreign tax is often left unclaimed. SMMT is offering our members a service that will help you recover VAT you have already paid with zero risk. Your business can submit claims up until 28 September 2012 to reclaim VAT expenses incurred abroad during 2011 (1 January – 31 December 2011). You may be able to recover VAT paid in EU outside UK for:

Hotel accommodation, Employee meals, Tradeshows & exhibitions, Conferences research expenses, Telecommunication charges, Entertainment, Car rental, Fuel, Transportation professional fees, Training courses, Management & consultancy fees, Rental & storage costs

# **Emerging markets round-up**



#### Argentina: Auto production & exports down y-o-y in June

*Thursday, July 05, 2012, AutomotiveWorld.com* Automotive production in Argentina plummeted 34.4% year-on-year in June 2012 to 52,983 vehicles.

#### Brazil: Vehicles sales to peak in 2015

Monday, July 16, 2012, AutomotiveWorld.com

Brazil's total vehicle market is expected to reach 3.77 million units in 2012, and rise to a peak of 4.29 million units in 2015.

Light vehicle sales in Brazil rose 4.6% to 3.52 million units in 2011, the eighth year of increase but the slowest rate of growth during that time. The slowdown primarily reflected a fall in economic growth to 2.7% from 7.5% in 2010 but there were also sector-specific factors at play including reduced availability of finance for car loans. The outlook for Brazil's GDP growth in 2012 has been steadily deteriorating and, all other things being equal, this would lead to an expected decline in light vehicle sales for the year. However, recent government action to reduce some vehicle taxes and boost vehicle finance availability is specifically targeted at boosting demand. The currently high rate of auto finance defaults is a concern and the moves to boost availability could be storing trouble for the future.

According to *Automotive World's <u>Sales Forecast: Brazil's new vehicle market - prospects to 2016</u> report, the light vehicle market is forecast to reach 3.59 million units* 

in 2012, rising to its next peak of 4.08 million units in 2015 as GDP growth recovers to above 4%.

Heavy commercial vehicle demand, meanwhile, is expected to fall by 14% this year to 178,000 units. Beyond 2012, a return to growth is anticipated, buoyed by economic growth, in general, and, in particular, infrastructure spending, which will be substantial. The market is forecast to reach a cyclical peak of 212,000 units in 2015.

This amendment will incorporate updated minimum standards for new vehicles, and in particular will introduce Euro 5 for light vehicles and the equivalent Australian Design Rule (ADR) on the same date as it will be introduced in Australia. The Amendment also updates acceptable minimum standards for new vehicles built to standards from United States of America and Japan. It will continue existing minimum standards for used vehicles, pending a review in 2014. The proposed new emission standards are internationally recognised and accepted in the motor manufacturing industry.

## USA G/TBT/N/USA/715

2 July 2012

NHTSA is issuing this NPRM as part of the agency's on-going effort to harmonize vehicle safety standards under the Economic Commission for Europe 1998 Agreement. Following a vote in favor of establishing a global technical regulation (GTR) on automotive glazing, we are initiating the process for considering adoption of the GTR. The changes proposed in this NPRM to the Federal motor vehicle safety standard on glazing materials would better harmonize U.S. regulatory requirements with those of other industrialized countries, by modernizing the test procedures for tempered glass, laminated glass, and glass-plastic glazing used in front and rear windshields and side windows.

We believe that most of the changes in this proposal would constitute minor amendments that would harmonize differing measurements and performance requirements for similar test procedures. Many of the tests in the GTR are substantially similar to tests currently included in Federal Motor Vehicle Safety Standard No. 205. We believe that the most significant improvements proposed in the GTR include an upgraded fragmentation test designed to better test the tempering of curved tempered glass, and a new procedure for testing an optical property of the windshield at the angle of installation, to better reflect real world driving conditions than the current procedure used in Standard No. 205. Comments are requested on whether these and the other provisions of the GTR are suited for adoption into the Federal glazing standard.
