### High flying? How things have changed - no ifs, no buts!

I fear as I lurch towards retirement this year I may be reminiscing and looking back on life and career a good deal more than I ought for which I apologise but New Year is the perfect time both to look back into the past and to make new strategies and changes for the future. There was, for example, looking back, a time when I thought I might have been a highflyer, but things change, particularly in flying.

Experts tell us that there are 7.2 billion people in the world today. Other experts at the International Civil Aviation Organisation report that in 2012 some 2.9 billion people flew on scheduled services for business or leisure - and with their prediction of continuing growth at over 6% per annum we can assume that on average the equivalent of over 50% of the world population flew on a plane in 2013. So now you know why it was so busy last time you were at an airport!

It must be hard to comprehend from the *Photo-Shopped* and carefully posed image that adorns the top corner of this page that I come from an era when to travel by aeroplane was both pleasure and adventure. I must even admit in my youth to having been something of a plane spotter, able to recognise every airliner by its engine sound or distinctive shape.

My early high-flying career ambition, I confess, was to be a commercial airline pilot and what youth in the 1960's wouldn't when the RAF was still operating Spitfires out of Biggin Hill. This London RAF fighter station continued until 1967 when the military flying was restricted due to the air space then becoming too crowded with the increasing number of airliners flying to and from the new and fast growing Heathrow London Airport; where incidentally, as a young plane-spotter I could sit all day perilously close to the runway and watch the Viscounts and Britannias with their turboprop engines and the new jet Comet take off and land connecting London and Britain to the British Empire courtesy of BOAC and BEA.

Oh dear, aircraft, airline and empire are now all gone! My word how things change, but hold on - Heathrow is still there and may still have a great future unless The Mayor of London's plans for an entirely new London airport rise from the sea!

As a recent TfL report states, London generates more international business airline passengers than most cities and already has five airports meeting the needs of business and leisure travellers alike, helping sustain trade, tourism and investment. But Heathrow's pre-eminence as a global hub is at risk.

Heathrow, currently operating at 98 per cent of its maximum capacity, is becoming increasingly focused on a smaller number of markets and now serves fewer destinations than its European rivals. Meanwhile, larger European airports have the capacity to serve more destinations than Heathrow by a substantial margin. Twenty years ago, Heathrow served more than 200 destinations, and Paris Charles de Gaulle fewer than 180. The situation is now reversed. Today, the hub airports serving Paris, Amsterdam and Frankfurt all serve more than 250 destinations.

Heathrow presently lacks the capacity to expand to a greater number of destinations. It struggles to compete for routes to the new and emerging markets in Asia, Africa and Latin America without reducing existing frequencies or by eliminating one route to establish another encouraging a shift of hub operations away from congested Heathrow towards European rivals, who can operate more flights to more destinations. Heathrow's difficulty is evidenced by the lower number of seats per week offered to mainland China compared to other European hubs.

In December 2013 Howard Davies' "*Airports Commission: Interim Report*" was published and a decision is now awaited on the future of London's airports. Initially three options were proposed: two for a bigger Heathrow and one for an additional runway at Gatwick. The Mayor of London's preference for a new Isle of Grain airport was rather side-lined as being worthy only of "further study" whilst Stansted's possible upgrade to full status appears to have been ignored altogether. Clearly the Davies momentum and airline lobby is backing an expansion of Heathrow.

You may recall, however, that David Cameron promised before the election that when he became prime minister there would be "no new runway at Heathrow, no ifs, no buts". But, things change. Indeed, all the Davies proposals, including Heathrow, are now relegated once again to the back burner, delaying the decision inevitably until after the next election when the political "hot potato" may have cooled a little, with politicians then jumping from fire to frying pan when the chips will at last be down. Let's hope that its not a recipe for disaster.

Yes, everything changes – not least the planes themselves. Now every plane looks and sounds just like every other to all but the most fervent plane-spotting anorak with just two companies now making most of the world's jet engines and another two making nearly all the world's airliners with Boeing and Airbus fighting for every order for the latest Airbus A380 or Boeing 747-8 double-deck, wide-body plane promising ever cheaper, quieter, safer flying for their billions of passengers. Could we ever envisage a day when there would be only two global auto-manufacturers, but then there was a time when Great Britain had more vehicle manufacturers than any other nation – but things change.

And what about changes in airport security? To stop now just briefly by an airport perimeter fence and peer at a plane on a taxiway or runway can bring alongside in an instant an armed police response vehicle whilst police patrol even the most exclusive airport lounges with their Heckler & Koch MP5s and passengers now queue to pass through security systems that can remotely check out one's personal "distinguishing

marks" that in the old days we were able to still keep "private" or were simply required to be noted in one's passport!

And what of the airlines? BOAC and BEA no longer exist of course – merged together and joined up with the Spanish – who also incidentally own a chunk of what I remember used to be known as the British Airports Authority. Whilst Emirates, Qatar, Singapore, All Nippon, Asiana, Cathay Pacific, Etihad, Garuda Indonesia, Turkish Airlines and Qantas are now rated as being the top-ten "world's favourite airlines" with the originator of the slogan, BA nowhere in sight. We have even said adios to BA airlmiles or should that now be avios?

As for flying being a "pleasure and adventure" it is now, at best, routine and mundane and customer service, (a phrase defined by Wikipedia as "a series of activities designed to enhance the level of customer satisfaction – that is, the feeling that a product or service has met the customer expectation") is unfortunately often found only in the expectation and no longer experienced in reality!

But let's not set off into 2014 on a negative note. No, change is not all bad. London's airports are no longer at Hendon and Croydon so that's evidence that new London airports do eventually get built and political decisions do eventually get made.

And it's no longer just business men and film stars who fly. Business trips now in fact account for under 20 per cent of the London passenger total – flying today is more about leisure and tourism.

We have budget airlines so everyone can fly because it is so cheap – many business trips are now routinely made on budget airlines. There is admittedly, the inevitable correlation, of course, that price matches quality. But don't despair because even low-cost flying may be changing.

For 2013 must be marked out as the year when Michael O'Leary, Chief Executive of Ryanair, the airline voted by consumer magazine Which readers in 2013 as "the worst of the 100 biggest brands serving the British market" has unveiled his new Ryanair future strategy.

He proudly announced at the AGM a new charm offensive by saying Ryanair in future must, in his own words, "be nice to customers – and not unnecessarily p--- people off."

No ifs, no buts, charm and offensive from Ryanair in one single future airline strategy, now I really know flying has changed!


### **International Market Reviews**

### The MINT countries – The next economic giants?

In 2001 the world began talking about the BRIC countries - Brazil, Russia, India and China - as potential powerhouses of the world economy. The term was coined by economist Jim O'Neill, who has now identified the "MINT" countries - Mexico, Indonesia, Nigeria and Turkey - as emerging economic giants. Here he explains why.

So what is it about the so-called Mint countries that makes them so special? Why these four countries? What they really share beyond having a lot of people, is that at least for the next 20 years, they have really good "inner" demographics - they are all going to see a rise in the number of people eligible to work relative to those not working.

This is the envy of many developed countries but also two of the BRIC countries, China and Russia. So, if Mexico, Indonesia, Nigeria and Turkey get their act together, some of them could match Chinese-style double-digit rates between 2003 and 2008.

Something else three of them share, which Mexican Foreign Minister Jose Antonio Meade Kuribrena pointed out, is that they all have geographical positions that should be an advantage as patterns of world trade change.

For example, Mexico is next door to the US, but also Latin America. Indonesia is in the heart of South-east Asia but also has deep connections with China.

And as we all know, Turkey is in both the West and East. Nigeria is not really similar in this regard for now, partly because of Africa's lack of development, but it could be in the future if African countries stop fighting and trade with each other.

Meade Kuribrena went so far as to suggest that, as a group of four countries, the Mints have more in common than the BRICs. Economically three of them - Mexico, Indonesia and Nigeria - are commodity producers and only Turkey isn't. This contrasts with the BRIC countries where two - Brazil and Russia - are commodity producers and the other two - China and India - aren't.

In terms of wealth, Mexico and Turkey are at about the same level, earning annually about \$10,000 ( $\pounds$ 6,100) per head. This compares with \$3,500 ( $\pounds$ 2,100) per head in Indonesia and \$1,500 ( $\pounds$ 900) per head in Nigeria, which is on a par with India. They are a bit behind Russia - \$14,000 ( $\pounds$ 8,500) per head - and Brazil on \$11,300 ( $\pounds$ 6,800), but still a bit ahead of China - \$6,000 ( $\pounds$ 3,600).
