Asia News Round-up

China: Nissan and Dongfeng form JV for Infiniti in China

22 September 2014, europeautonews.com

Nissan has formed a joint venture with Dongfeng Motor Corp. in China, dedicated to producing premium Infiniti vehicles in the world's biggest automobile market. Nissan, which moved its Infiniti head office to Hong Kong two years ago, is targeting sales of 30,000 units this year in China, an 80 percent jump from a year ago. It aims to sell 100,000 Infiniti cars in China by 2018, over half of which will be locally made, the carmaker added.

GERMANY: Volkswagen plans luxury sedan for China

Volkswagen plans to launch a new luxury sedan, codenamed 511, under the VW brand and only in China. Reuters, citing anonymous sources, said the model, intended to improve group profit margins, would be launched at the end of 2015. The automaker plans to sell 50,000 a year.

INDIA: Hyundai expects growth in rural areas

Following Toyota India's recent announcement of a new marketing push in rural areas, Hyundai Motor India said rural sales accounted for 20% of its tally for August 2014, compared with 12% in 2011. In the next few years, the company aims for 30% of its total sales to come from rural markets.

MALAYSIA: 'National carmaker' Proton launches new Iriz subcompact

Proton launched the Iriz subcompact car in Malaysia on Thursday, hoping it will help the national carmaker regain ground lost to key domestic competitors including Perodua. The new model comes with a choice of 1.3- and 1.6-litre VVT Euro IV engines and retail prices range from MYR42,438 (US\$13,000) to MYR58,268 (\$17,860).

SOUTH KOREA: Tata and LG in component supply talks

India's Tata Motors - parent of Jaguar Land Rover - is in talks to source vehicle components from LG group with reports saying high level talks took place in recent weeks. The South Korean electronics giant is a major global supplier of lithium-ion batteries, fuelling speculation that Tata is considering moving into the electric vehicle segment.

SOUTH KOREA: Analysts see hybrid car sales soaring with new government incentives

Sales of hybrid electric cars in South Korea are expected to accelerate next year with government incentives expected to make some local models actually cheaper to buy than equivalent petrol models.

SOUTH KOREA: Report says EV infrastructure will grow 73%

South Korea's electric vehicle charging infrastructure will grow 72.7% by 2020 to reach 90,000 stations, according to new research. The growth will be driven by demand for rapid-charging outlets and come on the back of the government subsidies for both the hardware and the installation costs.

VIETNAM: Lower import tariffs spark manufacturing exit fears

Fears are being expressed that the end of import tariffs on built-up car imports to Vietnam (under trade agreements) could cause manufacturers with assembly plants to quit Vietnam unless there are compensatory tax breaks from the government. [...]

Reuters noted that Vietnam currently imposes a 50% tariff on fully built-up imported vehicles, but tariffs in the region are planned to be scrapped in 2018. That could mean imports from other countries in the region - such as Thailand and Indonesia - undercut locally made vehicles.

The car-sharing program will begin in the cities of Rio and Curitiba, with initial 50 cars each. Then it will be extended to São Paulo, Belo Horizonte, Recife and Caxias do Sul. The company counts on a demand of 300 cars in each of these cities over time.

The future plans include an electric van and a special car for wheelchair users. The electric motor and battery will be supplied by manufacturers from the United States, England, Canada and China, attested by the English group Lotus, the same one used by Tesla, the American manufacturer of luxury electric vehicles. Motor Vehicles – General Requirements

Draft for update of the technical regulation No. GSO 42:2003 SUMMARY:

This standard is concerned with the general requirements for motor vehicles ensuring high levels of safety, environmental protection, energy efficiency and antitheft performance. For detailed requirements refer to GSO Technical Regulations on the subject concerned. GSO technical regulations related to Motor Vehicles will be formulated based on UN/ECE regulations; In the case of motor vehicles manufactured in compliance with FMVSS regulations, will be accepted as an alternative.

JCCC updates

Customs Information Paper (14) 64 Commercial Samples Relief – Changes and New Notice

Commercial Samples Relief is one of several Customs procedures available for trade promotion purposes. The Relief allows established businesses in the UK/EU to import samples of products for demonstration with the sole view to solicit potential orders of those products, provided that the sample items have been adequately prepared prior to import.

Adequate preparation must involve:

- Tearing, altering, perforating, slashing or defacing the items, and/or:
- Using permanent indelible marking or permanent labelling to clearly mark the item as a 'Commercial Sample'.

Any entity established in the EU with a current EORI (Economic Operator's Registration Identification) can continue to use this Relief – any entity that does not have a valid EORI will have to apply for one.

With effect from the date of this CIP, the use of Commercial Samples Relief by 'private individuals' will cease. It should also be noted that as announced previously in CIP (12) 61 the use of dummy EORI 'GBUNREG' is under review and consideration is now being given to its removal from use.

Relevant to All current importers, freight/shipping agents, freight forwarders, brokers and traders who use Commercial Samples Relief via CPCs 40 00 C30 and 49 00 C30. Effective from 1st November 2014.

Amendment to the Value Added Tax (Imported Goods) Relief Order 1984

VAT legislation on low value consignment relief for goods sent by mail order from the Channel Islands. Relevant to Individuals and businesses involved in importing goods from the Channel Islands. Effective from 26th September 2014.

Customs Information Paper (14) 62

Temporary Storage and Approved Depositories, Rebranding Approved Depositories to ETSF (AD), Revised Guidance

Clarification of the rebranding of Approved Depositories to External Temporary Storage Facility (Approved Depository) ETSF (AD) plus the revision of associated guidance and Public Notices. Relevant to All international trade economic operators and trade bodies, importers, exporters and shipping agents involved in Temporary Storage and Approved Depositories. Effective: immediate.
