SMMT's Climate Change Agreement

Reduce the tax bill on energy by joining SMMT's Climate Change Agreement

Businesses with paint shops, press shop foundries and plastic injection moulding facilities could be eligible to enter the SMMT climate change agreement (CCA). This would entitle you to a 90% discount on the climate change levy (CCL) on electricity and 65% discount on gas.

SMMT's new CCA started on 1 April 2013 and is set to save the sector over £10 million per annum. To save over £10,000 per annum on your CCL bill by being in a CCA, contact Matthew Croucher at
