With the process for reclaiming tax being quite complex, foreign tax is often left unclaimed. Foreign VAT rates of up to 25% are incurred by many businesses however it is the third largest controllable corporate expense. SMMT is offering members a service that will help recover VAT already paid with zero risk.
