# Editorial David Croxson Head of International, SMMT



# Is it time to go international with our innovation? If it takes great brains then I really can't say!

Many of you will be aware that in accordance with the label on the proverbial tin, the International team at SMMT contains a truly international mix. My team members include Pat from Mexico, Ruta from Lithuania and Sarah from France, while I am from Great Britain. This can produce a wonderful opportunity for us all to learn from one another's cultures and to see the world from a different national perspective.

Intriguingly, one of our regular International Bulletin readers recently wrote to me following my April editorial to suggest that in retirement I should publish my anecdotal memoirs saying: "I'm sure that they would be a big success for promoting "Britishness" as a lifestyle, and with *Daily Telegraph* and *Times* readers who would recognise many of your sentiments."

However, as Head of the SMMT International team and with the automotive sector being such a globally diverse industry, while it was very kind of the reader to take the time to write, it got me thinking – perhaps it's time for me to moderate my editorial prose and recognise that as Head of the department and in line with my team's different outlook, it is time for me to display a less British and more *international* perspective. After all, as I am always invoking you exporters - its international time!

My international understanding was particularly "enlightened" during a recent interlude in the office with one of my team stating that the Roman Empire was greater than the British Empire, (she will remain anonymous of course. I shall not even reveal her *nom de plume*) but I really did not know what to say, I was quite lost for words!

As a purely historical note it is timely that I mention here, perhaps, that in the 11th century, when the Normans invaded peace-loving England (there are, you know, still 22 countries at least that Britain has never fought in), only French and Latin was spoken by rulers and clergy. The English yeomanry, however, hung on to their language and, although for a hundred years or more books were not written in English, the English still insisted on speaking English. Of course, as true internationalists over the years we have absorbed Latin and Greek words and added them to English words with others from Norman French, Old German and Old Norse and together they have made English richer, more subtle, more precise; both practical and poetic.

This is surely one of the British people's greatest achievements, first saving our language from foreign competition, and then letting it grow freely, open to global competition as it were, with the people deciding which words they chose to use and keep and which words they'd lose.

That also, perhaps, is a metaphor for how we should regard international trade, it should be allowed to develop largely unfettered by government's intervention.

In the intervening years we have invented and added a million new English words, including half a million technical and scientific terms. Meanwhile, German now has about 185,000 words and French has fewer than 100,000 ( perhaps explaining their being at a complete loss for words when meeting me!)

An idle thought for you to ponder mid text - if our forebears had been able to patent the English language— might we now simply be offering users an annual licence fee renewal and living happily ever after from the royalties like Bill Gates and Microsoft?

But I digress. I was of course quite unable to counter my colleague's very persuasive argument although it did at times remind me of Monty Python's *Life of Brian* sketch – "What have the Romans ever done for us?"

I therefore list at the back of this month's IB a handy referenceof key world innovations - one or two inventions and discoveries that surprisingly did not come from Rome. Though quite how they came about is not altogether clear (particularly if you are not British). I might also have referred my colleague to the current ITV series "I Never Knew That About Britain", but she unfortunately does not choose to have the benefit of that surely indisputably British invention, a television set. Besides, I reminded myself, it was indeedtime for me to change my ways.

But while talking of time, it is only appropriate that I remind readers, *en passant*, that it was Britain that created the concept of Greenwich Mean Time (GMT) or, as we internationalists correctly refer to it - UTC.

Greenwich Mean Time (GMT) as many will know, is a term originally referring to mean solar time at the Royal Observatory, Greenwich, where a system was first developed in around 1850 for tracking time based on the rotation of the Earth. The 1884 Washington conference established Greenwich Mean Time (GMT) as the international reference point, and it was used throughout the world without demur and for over a hundred years until 1970.

In 1970, however, a Coordinated Universal Time system was devised by an international advisory group of technical experts within the International Telecommunication Union (ITU) based on the International Atomic Time (an accurate atomic clock, incidentally, is another British invention) with leap seconds added at irregular intervals to compensate for the Earth's slowing rotation – so much better than GMT don't you find?.

Strictly speaking though, UTC is not a time zone but an atomic time scale which only approximates GMT in the old sense. ITU, in its wisdom, felt it would be best international practice to designate a single abbreviation for use in all languages in order to minimize confusion.

Unfortunately, unanimous international agreement could not be reached on using the English word order, CUT (Coordinated Universal Time) possibly because the French wanted their word order, TUC (Temps Universel Coordonné)! So, in the spirit of true international compromise, the internationally contrived acronym UTC was finally agreed!

In casual use, of course, for us world travellers Greenwich Mean Time (GMT) is the same as UTC but at least UTC has the important benefit of maintaining *l'entente cordiale* and hopefully this internationally balanced editorial has similar effect.

So before I end, and since it is time my International team colleagues tell me to be less focussed on Britain, here are some international time facts for other nations, which may be of interest on your global travels or at least for future pub quizzes:

- Although Russia is geographically spread over 12 time zones, it officially observes only nine.
- As Japan is located to the east of Vladivostok (southern part of Russian Far East) one would assume that its timezone would be either similar or ahead of Vladivostok time but it isn't. Japan time is two hours behind Vladivostok.
- China observes one single time zone UTC/GMT + 08:00 which makes it uncommonly wide. In the extreme western part of China the sun is at its highest point at 15:00, in the extreme eastern part at 11:00.
- Brazil sets its summer time by decree every year while some other countries observe summer time on a year-to-year basis.
- Some countries use different rules to start and end DST (Daylight Saving Time).
   For example, a law in Israel requires that summer must last at least 150 days.
- Antarctica uses New Zealand's time zone +12:00 during local winter and +13:00 during local summer (which is winter in the northern hemisphere), except for certain international ice stations facing nearer land masses such as Chile, who then adopt the nearest major land mass time zone.
- India straddles two time zones, but prefers to have one uniform time throughout the country. Rather than choose between GMT+05:00 and GMT+06:00 the government simply decided to split the difference.

And finally -

The International Space Station uses GMT – sorry I mean UTC!

# **ARGENTINA: Argentina and Mexico agree to boost trade**

Mexican Economy Secretary Ildefonso Guajardo and Argentine Industry Ministry Debora Giorgi have agreed to promote bilateral trade, especially in the automotive industry. The agreement was reached during the visit that an Argentine delegation made to Mexico City last month, officials said.

The officials discussed the automotive industry, in which trade is regulated by Economic Complementation Agreement, or ACE, 55, under the Latin American Integration Association, or ALADI.

The officials made a commitment to "improve efforts to move the integration process forward in both industries, especially in the auto parts sector, promoting mutual investment in said sector," the secretariat said.

Mexico and Argentina reached a trade agreement covering the automotive industry in 2012 that allowed them to resolve differences over quotas.

# **BRAZIL: Brazil to Simplify Importing During Global Events**

Goods shipped in for the World Cup and Olympic Games will be given contractual temporary entry. The Brazilian Federal Reserve has introduced a solution for the temporary entry of goods for the FIFA World Cup in June and the 2016 Olympics. Items entering the country needed for international sporting events such as production equipment and sporting gear will now have a simplified import admission system that will allow companies to forgo import taxes and ultimately save time.

Under the new rule, goods will go through a warehouse customs procedure and be admitted only for the duration of the specific events. This system will remain in place for future major exhibitions, fairs, and conferences.

# CHINA: Siemens, BAIC to jointly build parts for green vehicles in China

German industrial company Siemens and state-owned Chinese automaker Beijing Automotive Industry Holding will form a joint venture to produce motors and inverters for hybrid and full-electric vehicles.

Toyota will start to source hybrid components in China for its locally-produced Corolla and Levin models from next year rather than import them from Japan.

# CHINA: Jaguar Land Rover to start China production at the end of this year

Jaguar Land Rover plans to start building vehicles in China by the end of this year. The company will begin selling a Land Rover SUV built by its Chinese venture with Chery Automobile in Changshu, by early 2015. The plant will have an initial annual production capacity of 130,000 vehicles.

# CHINA: VW signals it will outsell GM in China for second straight year

Volkswagen forecast its sales in China will increase 10 percent or more in 2014, signaling that the company will outsell General Motors in the world's biggest auto market for a second-consecutive year.

# MEXICO: Free trade, lower wages drive Mexico's automaking boom

Mexico is winning thousands of new auto jobs by offering a compelling combination of lower labour costs, a mature supply base and access to transportation that makes it easy to export vehicles to the U.S.. South America and Europe.

Twenty years after U.S. President Bill Clinton signed the North American Free Trade Agreement, Honda and Mazda opened two assembly plants in Mexico in less than a week. The factories, in the central Mexican cities of Celaya and Salamanca, represent an investment of more than \$2 billion. Between 2013 and 2015, Honda, Mazda, Nissan, Chrysler and Volkswagen automakers will invest \$6.8 billion in Mexico, according to Free Press research.

In addition to NAFTA, Mexico has 10 other free trade agreements covering 43 countries, according to ProMexico, an economic development arm of the Mexican government.

# SOUTH KOREA: Hyundai steps up green car programme

Hyundai Motor said it plans to target a greater share of the rapidly expanding market for low and zero emission vehicles, following the launch of the fuel cell electric Tucson SUV last week.

### **USA: Ford starts Transit van build at Kansas City**

US\$1.1bn spend and the creation of 2,000 jobs, Ford's Kansas City Assembly Plant has begun Transit van production, heralding the eventual end of the long-running domestic E-series line.

The full size van line goes on sale in the summer aimed at tradespeople and businesses with increased capability and new configurations compared to its predecessor.

It's the latest One Ford model for global sale, using common platforms. Variants including the smaller Tourneo/Connect variants are built in other plants in Turkey and Spain and by joint ventures with Sollers in Russia and Jiangling in China.

# USA: Ford's Mulally hands reins to Fields on 1 July

Alan Mulally, who has been president and CEO since September 2006, will hand the reins to groomed successor, COO Mark Fields, from 1 July. Mark Fields was named COO in December 2012 after previously heading the automaker's Americas region. He will also join Ford's board of directors.


