# Editorial David Croxson Head of International, SMMT



They say, stop whining and get exporting.

Mon Dieu – we are doing both already!

I have just returned from France – the trip was part holiday but primarily it was to sell a family property in Provence. Unfortunately, the experience turned out to be more stress inducing than relaxing holiday, as those of you familiar with French notaires and property dealings in France will fully understand!

The house sale unfortunately has yet to be completed. The outcome, however, was possibly jinxed from the outset by my having taken with me to France a bottle of English sparkling white wine to celebrate the sale - a very fine wine produced in the large Nyetimber vineyard located in my village in West Sussex (an unexpected benefit of global warming?).

The UK, I tell people in my travels, is now recognised as a premium wine-producing region, with English and Welsh wines winning many prestigious international awards. Well, that's what their trade association website states anyway!

Whilst offering the English wine in France, I perhaps should also not have mentioned, "en passant", that the "Method Champenoise" was actually invented in 1662 by English scientist and physician Christopher Merret some six years before Dom Perignon ever set foot in the Abbey of Hautvillers and that Merret's discovery happily coincided with another British technological breakthrough by English glass-makers that allowed bottles to be produced that could withstand the required internal pressures during the secondary fermentation process. (French glass-makers at this time could not produce bottles of the required quality or strength!)

Clearly, whilst UK technology and innovation may be at the forefront of creating export opportunities, whilst selling overseas one needs to heed the cultural niceties and adapt the sales pitch appropriately – but there again – I was giving the stuff away not trying to sell it!

On returning from France, however, it is clear that many of you exporters have indeed been successfully selling British quality stuff - products and services, technology and innovation, not giving it away like me and into many different overseas markets at that.

Official figures announced whilst I was in France record the best export performance since 2011 between April and June as the economy grew by a faster-than-expected 0.7%. UK exports reached £78.4bn in the second quarter, spurred by a jump in sales to the US and China.

Perhaps I should go away on holiday more often and leave you all to it!

The London Evening Standard reported that exports jumped by 3.6% over the quarter, with net trade contributing almost half of the GDP growth, raising hopes that the long-awaited rebalancing of the economy could finally be taking place. The Office for National Statistics has revised its headline growth figure up from its original 0.6% estimate a month ago. The ONS said exports of goods and services hit £43.2 bn. in June, the highest monthly total since records began in 1998. Exports of goods hit a record high of GBP26.9 bn. Exports to non-EU countries surged to GBP14.2 bn., also a record.

Business investment, which has slumped by more than 20% since 2008, also showed signs of life, growing by 0.9%. The Treasury hailed the figures as a further sign that the economy was picking up speed, following a host of positive surveys in recent months. "It's particularly encouraging that growth in exports and investment contributed well over half of the second-quarter growth rate," a spokesperson was reported as saying.

For a number of months UK exports to the EU had been falling, with the growing problems regarding the recession and sovereign debt issues. Figures show that exports to Germany fell by 9% for the second quarter of 2013. The UK has therefore focused its economic attention on other areas in the world such as Latin America and Asia, offsetting the slowdown in activity in the EU. However, with a return to better times being announced in the EU, the UK may also be able to benefit from that momentum and gain from increased exports generally to all markets.

In the second quarter of 2013, the UK exported more goods to countries outside the EU than to its partners within it but in a further possible hopeful sign for Britain's exporters, recent German GDP figures showed a healthy increase in domestic demand in the Eurozone's largest economy. Private consumption there rose by 0.5% over the second quarter whilst UK's trade with France and the Netherlands also improved in June, reducing the overall deficit in goods and services to £1.5bn from £2.6bn in May.

UKTI's recent introduction of increased Tradeshow Access Programme grant support is targeted at getting more UK companies to explore and develop export markets by attending trade shows, encouraging many new exporters as a result.

There are now over 400 vineyards in England and Wales covering some 3,500 acres producing sparkling and still wines. England is still a tiny producer by global standards, even in a good year picking enough grapes for just four million bottles. Yet whilst a relatively small UK industry 2013 nevertheless marks the first year that the English Wine Producers trade association has taken a 32.5m2 stand at Prowein the key European wine industry tradeshow held in Dusseldorf Germany, with a small group of UK wine producers exhibiting together as part of a UK Pavilion, hoping to develop sales or enter the European export market for the first time

If the UK wine producers can display with pride in the heartland of Germany's wine industry what about you seizing the opportunity to join SMMT as part of the much larger UK auto sector group that will again be exhibiting in Germany next year? SMMT will have 1500m2 UK stand area at Automechanika Frankfurt 2014. Don't miss out - see further details in this month's International Bulletin to reserve space. Incidentally, we will again be serving English wine on the SMMT stand – but this year, rather than taking it with us, I am rather hoping to be able to buy some in a local German supermarket when we arrive in Frankfurt next September!

Ford Motor Co. has made changes and added features to its Mondeo midsized sedan to woo China consumers as it aims to more than double market share there by 2015 and compete against segment leaders Volkswagen and General Motors Co.

Ford is introducing the revamped Mondeo, priced from 179,800 yuan (\$29,400) to 265,800 yuan, today, said Trevor Worthington, vice president of product development in the Asia Pacific region. The automaker expects to sell between 70,000 to 110,000 units of the model a year, he said.

Unveiling details of the strategy in Beijing on Tuesday, Daimler's new China chief, Hubertus Troska, said the company would spend 2 billion euros (\$2.67 billion) over the next two years as it seeks to boost sales of Mercedes cars in China by a third to more than 300,000 cars a year by 2015.

#### **Businnes Visit to Mexico**

### **Riding The Mexican Wave**

In July, SMMT led the first automotive-focused group visit to Mexico for many years. The participating companies – who included OEM component makers, commercial vehicle equipment suppliers, aftermarket distributors and manufacturing equipment/software providers – spent a busy week visiting the key automotive centres of Monterrey (Nuevo Leon State), Leon (Guanajuato State) and Mexico City. In each location, the programme, organised by UKTI's in-market experts, offered opportunities for company presentations, one-to-one meetings and visits to major automotive sites.

The rationale behind this visit was the rapid expansion taking place in Mexico's automotive industry, and the growing range of business openings that have been identified by UKTI/SMMT. Members of the visiting UK group confirmed that they had been "substantially surprised" by the level of opportunity offered by Mexico, and they recommend that other British companies should take a fresh look at the market. They all have significant business leads to pursue, and one participant is already planning to open a new manufacturing facility in Mexico, in preference to the BRIC market that they were previously considering.

SMMT also used the July visit to forge closer relations with the Mexican automotive trade associations, and with investment agencies and local industrial groups in the key automotive centres. As a result, SMMT – in conjunction with UKTI – is ideally place to assist companies wishing to investigate this booming market. We are also planning to run another business group visit in 2014.

#### **Auto Tuning in China- calling interested UK exporters**

100 million, this is the current total number of vehicles in China, where both auto sales and production continue to witness strong growth. With auto ownership rapidly embraced by common Chinese people, there inevitably emerge stronger demands for various customised features and individualities. In 2012, about 60% of car buyers were born in the 1980s, which constitutes another ongoing boost to potential demand growth. In short, more and more Chinese car-owners will bear the thought - 'what could I do with this car to make it MY car?'

Auto tuning and modifying business in China is growing at a fast pace. More and more modified cars are running on the road, auto tuning/modifying clubs are increasingly popular and an expanding series of auto tuning-featured exhibitions/road-shows have sprung up. With market value projected to reach £1.4billion by 2015, auto tuning is fast becoming an important and exciting slice of the huge aftermarket pie in China. More and more auto-tuning companies from Europe, US and Japan have already set their eyes on China, especially the prospering major cities.

Due to government's regulations on auto performance-related modifications, a good part of the business now still focuses on outside look and interior. But along with the rapid development of this sector and unquenchable demand from market, maturing of regulations are to be well expected. Ministry of Human Resources of China has already taken 'Auto Tuner' under its formal vocation qualification framework. Against the backdrop of sustainable auto market boom in China, the rising business of auto tuning does nourish a considerable wealth of potential.

#### Analysis: Slow progress for Indonesia's small car programme

Indonesia's government announced broad plans for a small-car incentive programme in 2010. Progress has been slow, but a number of manufacturers are now participating in the Indonesian scheme. Tony Pugliese reviews progress to date.

Suzuki Motor this month confirmed plans to participate in Indonesia's Low Cost Green Car (LCGC) incentive programme and these will be integrated into its JPY 60 billion (USD 610 million) new car plant investment in Bekasi, just east of the country's capital city Jakarta.

The Indonesian government originally announced broad plans for the LCGC small-car incentive programme in 2010, along with a package of investment incentives including five-year tax holidays (which are available to investments of over USD 100 million from a broad spectrum of industries), as a means of competing with the equivalent Thai "eco-car" programme.

What the government wanted to avoid most of all is for the country to become even more dependent on imports of passenger cars from Thailand, especially with its domestic vehicle market set to overtake that of Thailand in the near future.

Currently, most sub-compact, compact and medium passenger cars and pickup trucks sold in Indonesia are source as completely-built-up (CBU) units from its South-east Asian neighbour.

The main LCGC specifications are similar to the Thai Eco-Car: fuel consumption of 20km/litre; a petrol engine capacity of between 980-1200cc and up to 1500cc for diesel cars. These cars are to enjoy luxury taxes discounts of up to 75% compared with equivalent conventional models.

Additional requirements for the LCGCs include that they must run on higher octane fuels than the locally subsidised Premium and Solar fuel, such as RON92 gasoline or CN 51 diesel, and must have "premium" features such as airbags. The off-road sale price should be capped at IDR 95 million.

Suzuki is developing a car based on its Japanese Wagon R "kei car", but will substitute the 660cc engine with a more powerful 1,000cc engine. Suzuki expects to complete construction of its new plant in mid-2014.

Daihatsu and Toyota have been onboard the LCGC programme since its inception. The two companies launched the Daihatsu Ayla and the Toyota Agya - their respective five-seater LCGCs - at last year's Jakarta Motor Show.

Astra Daihatsu Motor completed construction of a new purpose-built, 130,000-unit/year plant in Karawang – some 70km east of Jakarta - at the end of 2012, designed to produce both the Agya and Ayla models.

The plant cost IDR 2.1 trillion (US\$220m at the time) to build and features full stamping, welding and painting facilities as well as a 1km test track. The two companies also completed their respective engine assembly plants in the third quarter of 2013.

While Toyota and Daihatsu dealers have been taking orders for the LCGCs some time, they are able to offer only tentative prices and no close approximations of the delivery dates.

A tentative on-the-road launch price of around IDR 70 million (USD 6,400) has been set for the manual version of the Daihatsu Ayla; and IDR 80 million for the Toyota Agya equivalent. This is a price level that would ensure substantial local demand.

All models will be fitted with 1,000cc engines and automatic transmission variants will cost around IDR 100 million.

Suzuki is expected to place its LCGC at the lower end of the Toyota-Daihatsu price range, which would allow it to compete effectively in what is expected to be a significant new market segment.

Honda has also announced tentative plans to join the programme, which will likely be accommodated in its USD 329 million, 200,000-unit/year plant currently being built also in Karawang. Nissan is also indicated that it may join the programme.

While low-cost cars in this price range have been on the market for many years, including the Chery QQ which is currently priced at IDR 90-95 million, the uptake has been very poor. Only a heavy-weight brand such as Toyota is capable of establishing a veritable new market segment in a South-east Asian market such as Indonesia.

So far, Astra Daihatsu has been able to produce only its existing compact MPVs at the new plant since construction was completed at the end of 2012. According to Asia consulting firm AsiaMotorBusiness.com, the government has yet to give its final approval for Daihatsu's LCGC and is still working out some technical issues.

Luckily for Daihatsu, demand for the best-selling Toyota Avanza and Daihatsu Xenia MPVs models has continued to rise to record levels this year and some of the new capacity has been put to good use.

### EUROPEAN UNION G/TBT/N/EU/141

8 August 2013

Regulation (EU) No 168/2013 of the European Parliament and of the Council of 15 January 2013 on the approval and market surveillance of two- or three-wheel vehicles and quadricycles sets out general requirements on the functional safety, environmental performance and vehicle construction of these vehicle types and repeals 15 directives. The Commission is empowered to adopt the specific technical requirements and test procedures through delegated acts. This draft is the second delegated act, out of a foreseen total of three. It sets out the specific requirements and test procedures in the area of vehicle construction. Many of these technical requirements and test procedures are carried over from the repealed Directives and, adapted, when necessary to technical progress. Others are newly developed in order to reflect the new vehicle construction provisions included in Regulation No 168/2013. As far as possible, the requirements are based or make directly reference to international requirements adopted under the UNECE framework (Revised 1958 Agreement). This is in line with the CARS 21 recommendation to strengthen international regulatory harmonisation and represents a clear benefit for manufacturers.

#### UGANDA G/TBT/N/UGA/339

22 July 2013

This Final Draft Uganda Standard specifies the requirements for speedometers, mechanical odometers and chronotachgraphs for motor vehicles. Prevention of deceptive practices and consumer protection.

#### EUROPEAN UNION G/TBT/N/EU/138

22 July 2013

This proposal for a Regulation specifies the obligatory requirements of the eCall in-vehicle system for cars and vans. It also amends Directive 2007/46/EC to take into account this new requirement. The proposal envisages the mandatory fitting of a system that in the case of a severe crash will automatically send information and launch a voice call to the nearest national emergency service (112 number).
