# EU Vice-President discusses transport's potential in smart cities

EU Vice-President Siim Kallas, has highlighted the potential role that transport can play in the move to increasingly 'smart' cities at a conference in London to mark the City Climate Leadership Awards. Mr Kallas noted that the urban environment is where many of transport's negative impacts are felt the strongest. stating that this is why urban transport lies at the heart of the European Commission's plans for sustainable smart growth and the transition to a resource-efficient economy. Mr Kallas highlighted the success of the CIVITAS programme, which promotes city initiatives for low-emission vehicles, improved safety and reduced congestion and noted that the EU will continue to support EU countries to develop and implement sustainable urban mobility plans to promote cleaner local transport, particularly public transport. He also highlighted London's investment in recharging infrastructure as a positive step, but noted that the move to cleaner fuel is still held back by the high cost of vehicles, a low level of consumer acceptance, and insufficient numbers of recharging and refuelling stations. Mr Kallas noted that by the end of 2013, the EU's new funding programme for research and innovation - Horizon 2020 - will start. Of its overall budget, the proposed allocation for transport research is € 7.7 billion, which is a 50 % increase on the current budget. Urban transport, logistics, green vehicles and infrastructures are priority areas for funding. Mr Kallas closed by noting that the Smart Cities initiative is not an EU funding programme but a partnership that brings together people, business and organisations to integrate different aspects of innovative technology across the transport, energy and ICT sectors. A Strategic Implementation Plan on the initiative is planned to be announced by mid-October.

# Commission publishes report on trade protectionism

The European Commission has released a report which states that global efforts to battle trade protectionism need to be reinforced to help shield the economic recovery across the world. The report identifies around 150 new trade restrictions introduced over the last year, whereas only 18 existing measures have been dismantled. A total of almost 700 new measures have been identified since October 2008. when the European Commission started monitoring global protectionist trends. Commenting on the report, EU Trade Commissioner Karel De Gucht stated: "All of us need to stick to our pledge to fight back against protectionism. It is worrisome to see so many restrictive measures still being adopted and virtually none abolished. The G20 agreed a long time ago to avoid protectionist tendencies because we all know these only hurt the global recovery in the long run." (Source: European Commission)
