

# European Parliament sets out its policy priorities for 2013

The European Parliament has called for real economic and monetary union with greater democratic accountability, as a first step towards a stronger political union, in its contribution to the European Commission's 2013 work programme. Growth initiatives and better controls on national spending of EU funds were among several specific proposals put forward by MEPs. The joint resolution from members stated that the Commission should play "a full part" in the EU summits of October and December, where a roadmap for a stronger economic union should be agreed, with the aim to create a financial and fiscal policy framework and ensure greater democratic legitimacy. To achieve this outcome, MEPs want the Commission to immediately propose legislation under the ordinary procedure, which involves Parliament fully and guarantees transparency, stating that the first proposal should address the need for a genuine banking union, with increased supervisory powers for the European Central Bank (ECB). Members also called for the scope and use of the European project bonds, so far introduced only as a pilot project, to be broadened, calling on the Commission to table a detailed growth agenda, which should also include a strategy to fight energy price rises and their impact on citizens. MEPs further stated that compulsory "national management declarations" should be introduced, to ensure compliance with EU spending rules, backed up by independent evaluations of all EU-financed projects. ### President Barroso delivers State of the Union speech

European Commission President José Manuel Barroso has delivered his State of the Union speech, wherein he called for the launching of a wide-ranging public debate for a major transformation of the European Union into a "federation of nation states". The speech was delivered as news of Germany's Constitution Court's rejection of efforts to block the European Stability Mechanism - the eurozone's €500billion bailout fund – were announced. ### EU grants almost €200 million to support key transport infrastructure projects

The European Commission has selected 74 projects that will receive almost €200 million in EU co-financing from the trans-European transport network (TEN-T) programme to continue improving transport infrastructure across the EU. These 74 projects, selected as a result of the 2011 annual call, will use EU financial support for a variety of purposes, ranging from the construction and/or upgrade of current links, support of transport corridors, Public-Private Partnerships (PPPs) and innovative financial instruments. The 2011 annual programme call granted €198.63 million in total funding and aimed to finance the highest priorities of the TEN-T network. Commenting on the announcement, Commission Vice-President Siim Kallas, responsible for transport, stated: "The European Commission continues to support the construction and upgrade of European transport infrastructure to ensure its citizens can reap the benefits of a complete, safe and modern network. Moreover, the almost €200 million made available today will also help to support employment in the EU by allowing Member States to continue investing in

The survey reported that 56% of automotive CEOs feared that a lack of key skills could drag down growth. The global automotive industry needs to recruit the brightest engineering and scientific minds to work on advanced technologies ranging from alternative propulsion systems to autonomous driving vehicles, in order to ensure safe and sustainable mobility in the decades ahead. With the Your Future In Automotive website, FISITA seeks to highlight the diversity of roles available and celebrate the innovation and cutting-edge technology being developed within the automotive industry. The goal is to share this information with students and young engineers in order to encourage them to consider a future career in the ever-growing automotive industry.
