Mark Prisk addresses industry representatives at SMMT Parliamentary Reception

The Associate Parliamentary Manufacturing Group launched its 'Made by Britain' project to showcase the variety of products made in the UK and promote the nation's manufacturing industry. Over 40 UK manufactured products have so far been nominated by MPs, including several from the automotive industry. Technology Strategy Board announces funding for battery recycling projects

The Technology Strategy Board has announced funding for feasibility studies into the recycling and reuse of batteries for low and ultra low carbon vehicles. Almost £500,000 will be allocated to six companies -Axeon, Energy Cost Adivsors Ltd, LiFeBATT Ltd, Narec, OXIS Energy Ltd and TRL - who will carry out seven studies. The funding awards follow the companies' success in the 'Batteries for Low and Ultra Low Carbon Vehicles: Recycling and Re-use' funding competition, which was developed by the Technology Strategy Board with the assistance of the Office for Low Emission Vehicles (OLEV). Michael Hurwitz, Director of OLEV said: "I welcome the Technology Strategy Board funding in this area and congratulate the successful companies. Understanding the economic opportunities available from batteries after their primary use in low and ultra low emission vehicles is an important element of the overall picture. We want this to contribute to the UK's leading position in the design and uptake of these vehicles." (Source: Technology Strategy Board)

June commercial vehicle registrations up 12.7%

Figures released by SMMT this week show the recovery in the commercial vehicle market continuing, with June registrations up 12.7%. However the June new car market fell 6.2% to 183,125 units, continuing the trend seen over the past 12 months. Fleet demand continues to grow, up 2.0% in June and by 3.4% over the first half of 2011, and average new car CO₂ car emissions fell to a record low of 138.9g/km in quarter

two, below 140g/km for the first time. Paul Everitt, SMMT Chief Executive, stated: "June new car registrations continued to perform in line with industry expectations with robust demand in the fleet sector and a relatively weak retail market. The balance of demand makes this a tough time for vehicle manufacturers and their dealer networks. Slow, but steady economic growth in the second half of the year should see volumes increase, although the overall market is still expected to be around 1.93 million units". (Source: SMMT)
