1. Government publishes departmental business plans

The prime minister has published departmental business plans that set out in detail the work of government for the next four years. The plans include data such as financial information, Structural Reform Plans and departmental priorities. The plans will be refreshed annually and reported upon on a monthly basis. The publication of these plans is a key objective of the coalition government in making government and Whitehall more accountable and transparent, setting in place milestones to set during the course of this parliament. Prime minister David Cameron, deputy prime minister Nick Clegg and the head of the civil service, the cabinet secretary Gus O'Donnell, launched the plans. David Cameron said: "Reform will be driven not by the short-term political calculations of the government, but by the consistent, long-term pressure of what people want and choose in their public services - and that is the horizon shift we need. But more importantly the Business Plans will bring about a power shift by changing what government does." (Source: Number 10) transparency.number10.gov.uk/

2. Prime minister leads trade delegation to China

Prime minister David Cameron arrived in China with the largest British trade delegation ever to visit the country. The prime minister, the chancellor of the exchequer and other ministers have been joined by 50 British business and education leaders as part of a drive to increase trade between the two countries. Over 40 specific agreements dealing with trade, low-carbon growth and cultural and education initiatives were expected to be signed over the course of the two-day trip. Mr Cameron said: "The trip will provide a further step forward in UK-China relations, adding momentum to our commercial relationship and cementing an economic and political partnership that can help to deliver strong and sustainable growth and greater security for us all in the years ahead." Other issues being discussed include addressing global economic imbalances; the need for the completion of the Doha round of World Trade Organisation talks; progress on low carbon growth; and education co-operation. Following the summit, David Cameron will be travelling to South Korea for the G20 Summit. (Source: Number10)

3. Mayor's electric vehicle charging network to go live in Spring 2011 London's city wide electric vehicle charging network, 'Source London', will launch in Spring 2011, the mayor of London, Boris Johnson has announced. Source London, which will deliver 1,300 public charging points across London by 2013, is part of the mayor's plans for London to become the electric vehicle capital of Europe. The Source London network aims to create a single visual identity for electric driving across the capital, and allow members to charge their vehicles at any one of these public charging points for no more than an £100 annual

membership fee. In preparation for this new network a website has also been launched providing a 'one-stop-shop' of information on electric vehicles, including charge point locations across the city. Once Source London has been launched in Spring 2011 drivers will be able to sign up for the scheme online. The development of Source London, has been led by Transport for London in close collaboration with the London boroughs and a wide range of private sector partners including SMMT – with some playig a key part in funding and providing locations for the network's charge points. Boris Johnson said: "Major manufacturers are gearing up to launch more affordable, practical electric cars over the next few years, whilst the cost of traditional fuels is making petrol-free driving an increasingly attractive option." Mr. Cameron said: "I am delighted that some of the most experienced and successful people from business and our universities are working with us. To secure sustainable growth and to create jobs and future prosperity it is of critical importance that we do everything we can to demonstrate that the British economy is open for business."
