




Registrations full year 2017

- Overall annual demand falls -5.7% in 2017
- New car market still third biggest in a decade at over 2.5 million vehicles.
- December represents the ninth consecutive month of decline
- Appetite for electrified cars reaches record high - 120,000 AFVs registered, a 34.8% uplift.
- Diesel demand declines -17.1%, undermining progress on emissions and CO2






Manufacturing figures

- British car manufacturing falls **-4.6%** in November as 161,490 cars leave UK factories.
- Domestic demand declines -28.1% but exports rise
 1.3%.
- More than 1.5 million cars made this year-to-date, the majority for export to global markets.



Autumn Budget

Key announcements

- VED supplement to apply to new diesel cars first registered from 1 April 2018.
- Rise in Company Car Tax diesel supplement from 3-4% from 6 April 2018.
- £220m Clean Air Fund
- Continuation of PICG to 2020 with £100m for new battery electric vehicles and establishment of £400m Charging Investment Infrastructure Fund
- R&D expenditure credit to increase from 11% to 12% and an additional £2.3bn of funding for R&D.
- Freeze in fuel duty and end of fuel duty escalator for LPG.
- £3bn set aside for preparing for exiting the EU.
- £385 million to develop next generation 5G mobile and full-fibre broadband networks.









Diesel taxation

Autumn Budget

- VED supplement to apply to new diesel cars first registered from 1 April 2018, so that their First-Year Rate will be calculated as if they were in the VED band above.
- This will not apply to vehicles which are certified as meeting emissions limits in real driving conditions, known as Real Driving Emissions Step 2 (RDE2) standards.
- Announcement followed recent SMMT engagement with government.
- SMMT sent several letters to the Chancellor in response to the Budget. The final letter was responded to by Andrew Jones, the then Exchequer Secretary.

UK Automotive Brexit Priorities

SMMT position

- Single Market Securing continued membership of the Single Market to avoid creating tariff or regulatory barriers to trade between the UK and the EU
- Customs Union Securing continued membership of the Customs Union
- Talent Guaranteeing unrestricted access to talent across Europe
- Regulations Maintaining regulatory certainty and continuity for automotive
- Trade Securing integrity and UK's position in current EU trade deals and those under negotiation
- **Transition** Current arrangements should continue to apply should no future agreement be reached while negotiating exit terms

The global competitiveness of the European automotive industry and its highly integrated supply chain is a shared objective that European automotive businesses should work together to secure in Brexit negotiations.







Brexit political developments

EU/UK Negotiations

- 4 December attempt to agree progress from "phase 1" disrupted by intervention from DUP on NI regulatory alignment
- **8 December** European Commission decides that "sufficient progress" has been made and recommends European Council to allow "phase 2" negotiations to proceed.
- **14-15 December** Council agreed that phase 2 negotiations could begin in 2018 (starting with transitional arrangements and preparatory talks on future relationship)
- 10 January Philip Hammond and David Davis visit Germany pressing the case for a bespoke future partnership

Phase 1 agreement

- Agreed words on the priority areas of citizen's rights, the Irish border and the financial settlement. But "nothing is agreed until everything is agreed".
- **Irish border**: there will be "full alignment with those rules of the Internal Market and the Customs Union which, now or in the future, support North-South cooperation, the all-island economy and the protection of the 1998 Agreement."
- EU stance that **UK will remain full member of Single Market and Customs Union during transition period**, but without voting rights/representation, i.e rule taker. European Council notes UK intention for transition period limited to 2 years.



The good news!

London's January air quality 'best in 10 years'



London's air quality is within legal limits in mid-January for the first time in 10 years, City Hall has said.

The capital breached limits for nitrogen dioxide (NO2) by 6 January every year for the last decade, Mayor Sadig Khan said.

Mayor of London hails impact of air quality measures



The London Mayor's Office has claimed that the introduction of Low Emission Bus Zones in the capital has contributed to improvements in air quality at the start of 2018.

Legal limits set a maximum of 18 hours of 'very high' pollution levels – 200 ug/m3 for nitrogen dioxide – at any individual site, a target that some sites are still on course to exceed, although at a greatly reduced pace compared to previous years.

Air quality data published by the Mayor of London, Sadiq Khan today (15 January) suggest that London's NO2 hourly average limit has been exceeded in only eight hours across London so far this year: five hours at Brixton Road; two hours at Putney High Street and one hour at Park Lane, Croydon.

This represents a major improvement on 2017, when the first air quality target breach occurred on 6 January at Putney High Street.

According to City Hall, the introduction of Low Emission Bus Zones in the Putney and Brixton areas has contributed to the improvement.

- ClientEarth have launched a fresh challenge to the UK Plan published on 26 July 2017.
- A consultation on mitigation measures has been published. A response was sent on 12 January
- Roundtable with Scotland Transport Minister on 22 January
- Cardiff EV event 15 February, Welsh Assembly member will give the keynote speech

SMMT next steps


- Consult with members and prepare responses on all consultations
- Advise on individual city plans as they emerge
- Develop the air quality action plan to support CAZ cities and encourage uptake of ULEVs
- Engagement with regional Mayors
- Plan events in cities including for National Clean Air Day





EU New car CO₂ Regulation

UK and EU new car CO₂ emissions and EU targets




- UK average 121.0g/km in 2017 first increase on record (+0.8%)
- UK and EU performance close
- 2015 target had been met, but recent market shift makes 2020/2021 target more challenging
- New proposals look for 15% by 2025 and 30% by 2030
- Similar Regulation for vans
- SMMT to lobby officials on Regulation issues, including through CO₂ Report and launch event.


Market trends and rise of alternatively fueled vehicles
